June 10, 1950 - May 20, 2007

Edward S. Grygiel, age 56 of Dixon, died at Rockford Memorial Hospital Sunday May 20, 2007. He was born in Dixon June 10, 1950 the son of Stephen and Anna Marie (Wachowiak) Grygiel. He was a Chartered Property and Casualty Underwriter. He had been a Commercial Lines Manager with U.S.F. & G Co. in Dixon for 22 years, a Commercial and Personal lines Manager with Western States Insurance Co. in Freeport and a Program Underwriter with The Bituminous Insurance Co. in Rock Island. From 2002 until 2004 he co-owned and operated the Adams Brechler and Grygiel Co. in Dixon. He was a member of the Inland Marine Underwriters Assn. He was a member of St. Anne Catholic Church in Dixon, a member of the Knights of Columbus Council 690, Fr. Boland Assembly Fourth Degree, Dixon Elks Lodge 779, Freeport Order of Eagles, Past president of the Dixon Petunia Festival Board, Past president of the Dixon Noon Lions Club and a past member of the Dixon Area United Way. He was an avid fan of both the Chicago White Sox and Notre Dame. He was united in marriage to Nancy Tolle in Chicago Heights Illinois September 8, 1973. He was preceded in death by his parents. He is survived by his wife of Dixon; son Ryan Grygiel of Lakewood CO; daughter Jennifer Grygiel at home; sister Sue (Jerry Grzybowski) Burkhart of LaSalle; brother Ron (Linda) Grygiel of Dixon. Funeral services will be held on Thursday May 24, 2007 beginning with a 10:00 A.M. prayer service in the Jones Funeral Home in Dixon followed by a 10:30 AM Mass of Christian Burial at St. Anne Catholic Church with the Rev. Michael Morrissey, pastor,

officiating. Burial will follow in Oakwood Cemetery in Dixon. Visitation will be held on Wednesday May 23 from 2:00 until 8:00 PM with a scripture service at 7:30 PM in the funeral home. A memorial has been established.

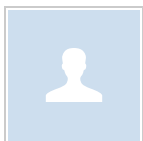
